- 1 To sign up via the web portal, direct your interested patients to: omnipod.com/freedom-trial
- 2 The Omnipod® Team will initiate an insurance coverage check for the Omnipod DASH® Insulin Management System once the electronic documentation is sent through the portal. (Insurance eligibility will be delivered to the patient approximately 1-3 days following coverage check<sup>4</sup>.)
- 3 In order for the patient to get started, a valid prescription must be faxed to: **IMCEAFAX-4170@insulet.com** or **877-467-8538**.
- 4 An Omnipod® Certified Clinical Services Manager (CSM) will contact the patient to set up the training session.<sup>67</sup>

**NOTE:** Patient may continue using the Omnipod DASH® PDM if they have pharmacy coverage or decide to cash pay.8
